As the number of people and communities affected by the COVID-19 pandemic grows, so do the scams associated with it. Scammers use public health emergencies as opportunities for new fraud schemes, and because older



adults and people with disabilities are at greater risk for serious illness from COVID-19, they may target these populations.

It's important to remember that although the Centers for Disease Control and Prevention (CDC) and other public health officials may contact you if they believe you may have been exposed to the virus, they will not need to ask you for insurance or financial information.

Scammers rapidly alter their tactics and adapt their schemes to the changing landscape, and we anticipate that they will leverage the COVID-19 vaccine to prey on unsuspecting people. 

13)Effects of Expanding Pell Grant Eligibility for Short Occupational Ttaining programs: Results from the Experimental Sites Initiative, Institute of Education Sciences 12/2020

"ED's spending on Pell Grants is now at close to \$30 billion annually. Some policymakers and stakeholders seek to expand the amounts awarded or who is eligible. Others question the increasing costs of federal financial aid and whether the grants, and the investment in short-term programs, encourage student success as intended (Kreighbaum 2019). It is therefore important to identify lessons for the future and still-open questions from this study, particularly given the potential costs of making the pilot eligibility expansions permanent policy. For example, if current very short noncredit occupational courses were eventually made credit-earning and eligible for Pell Grants, low-income students' participation might add as much as \$500 million more to federal financial aid expenditures.

This cost should be balanced against a potential 10-percentage point impact on program completion.23 Two important lessons stem from the way the study was conducted. This study was the first to evaluate the effects of offering Pell Grants using random assignment, the most rigorous methodology for assessing effectiveness. It was also the first time this method was used to evaluate a pilot under ED's Experimental Sites Initiative, in place since the 1980s. The use of random assignment lends credibility to a growing body of evidence about the benefits of Pell Grants for low-income students. Other evaluations use different methods, but some have also found that this form of aid leads to higher rates of college enrollment and completion, particularly among older, nontraditional students.24 The current study also underscores the feasibility of using random assignment in evaluating federal education programs, including financial aid, and in doing so on college campuses, as an increasing number of studies do."

To that end, the foundation is exploring the promise of coaching and navigation to improve economic mobility and reduce inequities. In June 2020, the foundation partnered with Mathematica to hold a virtual convening on the potential of coaching and navigation to promote economic mobility. This convening included a diverse group of experts, including designers and implementers of coaching and navigation programs, policy experts, researchers, coaches and navigators, people who had received coaching and navigation services, and foundation staff.



23) IRS Statement about Second Economic Impact Payments

https://www.irs.gov/newsroom/irs-statement-update-on-economic-impact-payments IRS and Treasury continue to work closely with our partners in the tax and financial industry to do everything possible to get the second round of Economic Impact Payments to the American people as quickly as possible.

At this point, over 100 million EIPs have been direct deposited into eligible recipients' accounts. Some recipients may have had their payment directed to the temporary bank account established when their 2019 tax return was filed. The IRS and tax industry partners are taking immediate steps to redirect stimulus payments to the correct account for those affected. The IRS anticipates many additional taxpayers will receive payments following this effort.

For those taxpayers who checked Get My Payment and received a response indicating a direct deposit was to be sent to an account they do not recognize, the IRS advises them to continue to monitor their bank accounts for deposits.

The IRS emphasizes that the information taxpayers see in the Get My Payment tool, including account numbers and potential deposit dates, may not display an accurate account number as we continue to work through updates. No action is necessary for taxpayers as this work continues; they do not need to call the IRS, their tax provider or their financial institution.







24) Updates to Unemployment Benefits

In December 2020, Congress passed legislation providing an additional \$300 per week to all workers receiving unemployment benefits. The supplement begins after December 26, 2020 and ends on March 14, 2021. The legislation also extends the Pandemic Unemployment Assistance program which provides unemployment assistance to the self-employed and gig workers. Contact your state's unemployment office or program for information or to apply for benefits.

You can look to your state's unemployment insurance office or program to identify current options for benefits.

suspended through January 31, 2021.

What you need to know

- Interest and monthly payments on federally-held loans are suspended through January 31, 2021.
- You do not need to contact your student loan servicer or take any action on your federally-held student loans.
- Make sure your servicer has up-to-date contact information and check your mail or email so you can
 receive any updates or information about your loans.
- Suspended payments through January 31, 2021, will count towards any student loan forgiveness
 program, as long as, all other requirements of the loan forgiveness program are met.
