# 11. Layoff Aversion Support Program (Trinh van Erp, DOR)

OC Workforce Development Board

The OCWFD Layoff Aversion Support Program was launched to financially help local small businesses mitigate layoffs and adhere to "social distancing" provisions. Eligible business may be eligible for up to \$10,000 in grant funds.

The first round originally announced in May awarded approximately \$444,000 of the \$700,000 in Workforce Innovation Opportunity Act (WIOA) funds received from the California Employment Development Division (EDD), leaving OCWDB approximately \$256,000 to award in this upcoming second round to support local small businesses impacted by COVID-19. Businesses must submit an application on the Orange County One-Stop Centers website at oconestop.com/covid-19-layoff-aversion-program to be considered for the grant funding. Eligible applications will be processed on a first-come, first-served basis until all available funds have been committed.



26. Position Statement on the Provision of Compensatory Ed in Response to Lost Education as a Result of COVID-19

"Under Reid v. District of Columbia, 401 F.3d 516 (D.C. Cir. 2005), the standard for compensatory education is not an hour for hour calculation. Rather, "In every case,

however, the inquiry must be fact-specific and, to accomplish IDEA's purposes, the ultimate award must be reasonably calculated to provide the educational benefits that likely would have accrued from special education services the school district should have supplied in the first place." Id. at 524. It is a qualitative standard based on individual assessments of the student.

between groups or individuals. The driving concept behind the theory of Social Capital is that a person's position within a particular group provides certain benefits that work to their advantage. Social Capital emphasizes commonality to strengthen communities. Social Capital is the effective functioning of social groups through interpersonal relationships, a shared sense of identity, a shared understanding, shared norms, shared values, trust, cooperation, and reciprocity. Social Capital is a set of shared values that allows individuals in a group to work together effectively to achieve a common purpose. Social Capital exists in a job seeker's network and can lead to potential opportunities and resources for employment. Social Capital also contributes to a company's success by building a sense of shared values and mutual respect.
