Communities across the state are spending the next weeks and months preparing for the forthcoming school year. To assist with that planning process, the following guidelines and considerations are intended to help school and community leaders



plan and prepare to resume in-person instruction. This guidance is interim. These guidelines and considerations are based on the best available public health data at this time, international best practices currently employed, and the practical realities of managing school operations; as new data and practices emerge, the guidance will be updated. Additionally, the guidelines and considerations do not reflect the full scope of issues that school communities will need to address, which range from day-to-day site-based logistics to the social and emotional well-being of students and staff; further guidance is forthcoming, including on school-based sports and extracurricular activities. Implementation of this guidance will depend on local public health conditions, including those listed here. Communities meeting those criteria, such as lower incidence of COVID-19 and adequate preparedness, may implement the guidance described below as part of a phased reopening. All decisions about following this guidance should be made in collaboration with local health officials and other authorities.

Implementation of this guidance should be tailored for each setting, including adequate consideration of instructional programs operating at each school site and the needs of students and families. School leaders should engage relevant stakeholders—including families, staff and labor partners in the school community—to formulate and implement plans.







### 11. Pandemic EBT...Deadline extended for local families to apply for food and grocery benefits

The application deadline has been extended for the Pandemic Electronic Benefit Transfer, or P-EBT, which helps struggling households pay for food and groceries.

Families now have until July 15 to receive up to \$365 per eligible child by applying online at <a href="https://ca.p-ebt.org/en/">https://ca.p-ebt.org/en/</a>.

The <u>Pandemic Electronic Benefit Transfer program</u> is administered by the California

Department of Social Services to assist students whose campuses were closed during the pandemic. Children who would otherwise qualify for free and reduced-price meals at their schools are eligible. P-EBT cards can be used just like debit cards, and students who receive benefits can still receive grab-andgo meals at COVID-19 emergency sites. Families with children who get CalFresh, Medi-Cal or Foster Care benefits do not need to apply. Most will get their P-EBT card in the mail during the month of May. If you already have a card or have applied online, officials say there's no need to apply again. Note that some recipients will not get their cards until August due to application processing and mail delays.



### 35. Could it be COVID? (Trinh van Erp, DOR)

Orange County residents with COVID-19 symptoms such as cough, difficulty breathing, fever, chills and more, can receive **free COVID-19 testing in OC**. Recent county statistics indicate 39% of people testing positive for the disease are Hispanic, 43% are multiple races or unknown,17% are white and 8% are Asian.

How does an OC resident schedule a test within the network?

- If a resident has COVID-19 symptoms fever, cough, shortness of breath, among other possible symptoms as identified by the CDC they should call their medical provider first.
- If the resident does not have a medical provider or their medical provider is unable to provide testing, they can call the nearest Testing Network found at <u>ochealthinfo.com/covidtest</u> or by calling the HCA's Health Referral line at 800-564-8448.
- Residents MUST make an appointment for testing with one of the clinics listed on the website to
  assure that they are eligible and that the test is available at that site. The county, like jurisdictions
  nationwide, is still facing challenges in obtaining testing supplies and personal protection equipment.
- The resident will receive a medical assessment before being tested and will be tested if they have symptoms of the disease.
- There is no out-of-pocket cost. If they have insurance, it may be billed but they will not have any copay. If they do not have insurance, there is no charge.
