

2. Bill to End Subminimum Wage Ready on the CA Assembly Floor with More Champions Effort to Ensure that California Employers Pay Workers with Disabilities Minimum Wage

9-2-2021

The State Council on Developmental Disabilities (SCDD) is pleased to announce that Senate Bill (SB) 639 by Senator Maria Elena Durazo (D-Los Angeles) is on the Assembly Floor with three new coauthors. Co-author Sen. Sydney Kamlager (D-Los Angeles) is joined by Assemblymembers Lorena Gonzalez (D-San Diego), Cristina Garcia (D-Bell Gardens) and Isaac Bryan (D-Culver City) on this bill that eliminates the subminimum wage in California once and for all.

Estimates are that around 12,000 Californians with disabilities are currently working in sheltered workshops and are being paid as little as 15 cents an hour under an antiquated federal policy dating back to 1938. While in recent years the number of employers seeking the certificates that allow them to employ people with disabilities has dramatically declined, there remains some exercising this employment option known as subminimum wage. Sponsored by the State Council on Developmental Disabilities, Senator Durazo introduced this bill to end the practice. If it becomes law, California will join 11 other states that have already prohibited paying less than the standard minimum wage to any employee.

Under SB 639, an inclusive stakeholder-led process would be used to develop the three-year phase-out implementation plan. This process will occur over several years and allows the stakeholders, such as state agencies, providers, university organizations, advocates and community members, working with the State Council on Developmental Disabilities, to develop a plan to successfully transition workers. This is a positive path forward and critical for both employees and employers. Due to be delivered to the Legislature by January 1, 2023, the implementation plan will provide status updates, recommended funding levels, specified data and more. Paying an employee with physical or mental disabilities less than the legal minimum wage would be illegal by January 1, 2025.

The Assembly will take up SB 639 next before it goes back to the Senate for its final vote. Additional information on SB 639 is available at scdd.ca.gov/sb639.

3. OC Bus Youth Ride Free Promotion

The youth right program is a promotional pass that allows youth 18 and under to ride all OC bus fixed route buses for free. The six-month program will start in September 2021 and passes will be valid through February 28th, 2022. Passes and marketing information will be distributed to in partnership Orange County schools, with parents able to request pass from participating schools, the OCTA store, or at ocbus.com/youth bride free. All 34 Orange County cities and the County of Orange are in the area of benefit program participants in Orange County ages 6 to 18 and the funding is from the state of California low carbon transit operations program.

As states strive to promote workforce inclusion, youth with disabilities are a key part of the solution. Over 1.3 million young people between the ages of 16 and 24 have a disability. Youth with disabilities face barriers in transitioning successfully from youth systems into adulthood which

results in lower employment outcomes, educational attainment, and community participation than their peers. To address these barriers, the U.S. Department of Labor's Office of Disability Employment Policy launched The Center for Advancing Policy on Employment for Youth (CAPE-Youth). CAPE-Youth is a collaboration between The Council of State Governments, the K. Lisa Yang and Hock E. Tan Institute on Employment and Disability at Cornell University, and the Transitions to Adulthood Center for Research at the University of Massachusetts Medical School. The Center works to improve employment outcomes for youth and young adults with disabilities by helping states build capacity in their youth service delivery and workforce systems. It conducts research, develops partnerships, and shares best practices. In addition, CAPE-Youth helps states identify new opportunities to expand career pathways, work-based learning, strategic partnerships, systems coordination and professional development for practitioners.

To fill this knowledge gap, the American Institutes for Research, under a grant funded by Walmart, conducted a scan of free college tuition program websites in spring 2021. This scan culminated in this project website, which contains an interactive map, a report, a downloadable database of programs, and a webinar that explores how free college tuition programs for adults might better leverage employers in establishing and advancing programs.
