The Self-Determination Program is all about an individual's choice and control over the services they receive through their regional center and the money that pays for those services.

The Self-Determination Program waiver was approved by the Centers for Medicare and Medicaid Services (CMS) on June 7, 2018. The initial 2,500 participants were selected October 1, 2018, and a second selection of participants were selected on November 22, 2019. After June 7, 2021, the program is now available to all eligible consumers.

"It's time to report your wages to the Social Security Administration...You can save Time and avoid processing delays by reporting wages online with a personal "my Social Security account "

You can now report your wages online using your personal and secure *my* Social Security account.

On a desktop, laptop, or mobile device, you or your representative payee can report your wages if you:

- Receive Social Security Disability Insurance (SSDI) benefits.
- Receive Supplemental Security Income (SSI).
- Receive both SSDI benefits and SSI.
- Are a spouse or parent who lives with a person who receives SSI.

After reporting your monthly wages online, you or your representative payee can save or print a copy of your receipt.

25. Youth Leadership Forum

The California Committee on Employment of People with Disabilities (CCEPD) is now accepting applications for the 2022 Youth Leadership Forum for Students with Disabilities (YLF), tentatively scheduled for July 17-22.

The YLF is a six-day residential self-advocacy and leadership development program for students with disabilities. Post-YLF workshops of specific topics have been added after the weeklong event. If there are any in-person restrictions due to the COVID-19 pandemic, the YLF may be held virtually via Zoom or in a hybrid format.

Students must complete an application, write an essay and provide letters of recommendations. Students will also be interviewed by a YLF partner team in their local communities. This is a competitive process and not all students will be selected. Applicants must be sophomores, juniors or seniors during the 2021-22 school year ending by June 30, 2022, to be eligible to apply. All selected delegate's expenses are sponsored through a public-private partnership.

YLF applications must be completed electronically and emailed to vlf@dor.ca.gov. The deadline to apply is December 17, 2021. We will examine when one might choose one option over the other. We will also provide guidance on how to take advantage of using an ABLE account and an SNT tandem.
