

# OCLPA Universal Referral Process

## **Technical Assistance Team Procedures**

The Orange County Local Partnership Agreement (OCLPA) has developed a Universal Referral Process (URP). An "Integrated Resource Team" (IRT) will determine needed services and supports of individuals with disabilities where there appears to be a need for multi-agency efforts in work-based learning and competitive integrated employment programming. The goal is to work together to create coordinated, well sequenced service delivery for individuals while optimizing the use of local partner resources.

The Year #3 Pilot Project was completed as of 8/31/21 and we are recommending a roll out to other education and service agencies. The agencies who participated in one year or more of the pilot phase include...

The goal of the OCLPA Universal Referral Process is to promote community based integrated work training and Competitive Integrated Employment (CIE). The definition for CIE is full or part-time work at minimum wage or higher, with wages and benefits similar to those without disabilities performing the same work, and fully integrated with co-workers without disabilities.
