



Our Mission as an Organization

In 1972, a New York television station produced an investigative series exposing abuses at Willowbrook, a state-run institution for children with intellectual disabilities.

Our Story

In 1975, Congress passed the Developmental Disabilities and Bill of Rights (DD) Act. It created the protection and advocacy system, designating an organization within each state and territory to advocate for the rights of people with disabilities.

In 1978, Governor Jerry Brown designated us as California's statewide organization under the name Protection & Advocacy, Inc. (PAI).

In 2008, we changed our name to Disability Rights California.

Who is Disability Rights California?

Disability Rights California (DRC) is a nonprofit law firm and advocacy organization for people with disabilities.



DRC Vision Statement

We envision a barrier-free, inclusive, diverse world that values each individual and their voice. In this world, all people with disabilities enjoy the power of equal rights and opportunities; freedom from abuse, neglect, and discrimination; dignity; and respect for their choices based on their own goals and values.

Our Advocacy Principles

With our patients' rights advocacy, clients' rights advocacy, and legal advocacy:

- We will do what the client wants - not what we or others think is best;
- We are honest about our limitations, values, resources and the likely outcome;
- The client chooses the outcome and the method of achieving the outcome and the client's choices will be treated with respect;
- The client actively participates in every stage of the process.
