The following is a list of resources that may be of help to you. We do not know if any of the attorneys on this list will be able to take your case. You will have to ask them.

We do not have information about the fees the attorneys on this list charge. We do not have information about whether or not the attorneys on this list have malpractice insurance. You will have to ask them.

The State Bar of California recommends that before you meet with any attorneys you do some "comparison shopping." Call several lawyers and ask questions that might help you make your decision. Ask about the attorney's experience and when he or she last handled a similar case. Ask about fees. Ask about whether the attorney has malpractice insurance. Write down what the attorneys have to say. Take time to think it over. Then choose the attorney who seems right for you.
