## 10. SWTCIE Grant Update (Adam Gottdank, NOCE)



Rehabilitation Services Administration (RSA) announced new five-year grant awards for the Subminimum Wage to Competitive Integrated Employment (SWTCIE) demonstration project to 14 state vocational rehabilitation (VR) agencies. The purpose of these grants is to decrease the use of subminimum wages and increase access to competitive integrated employment for people with disabilities. These VR agencies will receive funding from the Disability Innovation Fund (DIF) to support increasing access for people with disabilities to jobs that pay good wages.

Student Success Act of 2012: Matriculation & Assessment NORTH ORANGE Signed into Law 9/30/22

AB 1705 builds off a 2017 law, Assembly Bill 705, that said colleges can't place students in remedial classes unless they are deemed highly unlikely to succeed in transfer-level coursework.

Gov. Gavin Newsom signed Assembly Bill 1705, setting into motion changes that will severely restrict the ability of community colleges to offer remedial math and English courses. The legislation creates new rules that mostly prevent colleges from offering those courses, which can't be used toward transfer to four-year universities.

The bill was among a package of higher education bills that Newsom signed Friday. He also signed AB 1187, which will expand tutoring at community colleges, "Reforming remedial education and expanding access to tutoring will help millions of Californians complete their education faster," Daisy Gonzales, interim chancellor of the community college system, said in a statement.

# 12. Vanderbilt University has been awarded a \$50,000 National Science Foundation Grant

They will explore an integrated artificial-intelligence and behavioral UNIVERSITY on Disability science-based drivers-training (AIDT) system, specifically designed for neurodiverse individuals, to address the large need of transportation independence. The project will bring together a broad-based coalition of community stakeholders — including vocational training centers, schools, clinics, and insurance providers — to understand how to package the AIDT system for seamless deployment across the community, effectively train community service providers in its use, and develop mechanisms within the community for its financial sustainability. Orange County will be one of the test sites, if Stage 2 is funded in the Spring 2023.



YLF is a six-day leadership program for students with disabilities, which will be held through a combination of online Zoom sessions and in-person activities in Sacramento (At California State University, Sacramento). Students will learn advocacy and leadership skills from alumni and professionals with disabilities and create a "Personal & Career Leadership Plan" to help reach their future education, independent living, and career goals.

Students interact with state and national leaders with disabilities, which may include celebrities, politicians, entertainers, and other adult role models with disabilities. Participants also make lifelong friendships with other statewide delegates and have mentorship opportunities with alumni. There is no cost for students who are selected to attend. Delegates will be provided with any additional technology and reasonable accommodations, they need to attend online sessions, and all costs including travel, lodging, meals, and accommodations will be covered for the sessions in-person in Sacramento. Funding for YLF is provided through a public-private partnership.

# 36. Congress Faces Pressure to Raise SSI Asset Limits (Scarlett VonThenen, SCDD) Disability Scoop, Michelle Daiment, 11-1-2022

Disability advocates are pressuring lawmakers to include a bill known as the SSI Savings Penalty Elimination Act in a broad legislative package that's expected before the end of the year. Individual SSI beneficiaries can currently have no more than \$2,000 in assets at any given time in order to retain their monthly benefits. Married couples are limited to \$3,000 under rules that have not changed since the 1980s. However, under a bill introduced earlier this year by U.S. Sens. Sherrod Brown, D-Ohio, and Rob Portman, R-Ohio, those limits would increase to \$10,000 for individuals and \$20,000 for married couples and SSI's asset limits would be tied to inflation to ensure that they keep pace in the future.
