Section 1: Overview

Justice Counts is a national collaborative initiative to improve the accessibility and usability of criminal justice data across the country. Co-led by the U.S. Department of Justice's Office of Justice Programs' Bureau of Justice Assistance (BJA) and The Council of State Governments (CSG) Justice Center, <u>Justice Counts</u> is supported by an unprecedented coalition of partners from across the criminal justice system, which is led by a 27-member national steering committee. Together with BJA and the CSG Justice Center, these partners helped to design the three core components of Justice Counts:

- 1) Consensus-driven metrics that help agencies focus on sharing the most critical data that policymakers need to make effective decisions;
- 2) A set of tools agencies can use to easily publish those metrics; and
- 3) Assistance to help agencies effectively and efficiently share data that answers policymakers' most frequently asked questions and better frame the narrative about their work to decision-makers.

The mission of Justice Counts is to empower criminal justice agencies to easily share accurate, nuanced data that makes sense for them. On January 30, 2023, Justice Counts will release an innovative tool to meet this need—a set of first-of-their-kind Technical Implementation Guides. These guides enable a new data-sharing approach, equipping criminal justice agencies with the resources they need to publish data that is both comparable to other agencies nationwide and customized to the realities of their own unique operations.

Mirroring the digital infrastructure where participating agencies will publish data, the guides offer suggestions for how often to share data, customizable definitions for metrics, and detailed lists of data elements that agencies can choose from according to what is relevant to them and their work.

Beginning on January 30, 2023, the guides will be available for any agency to explore on <u>the Justice Counts</u> <u>website</u>. Agencies that have opted into Justice Counts will use the same framework to configure their data in the digital infrastructure, taking a major step forward in meeting the Justice Counts mission to provide timely and useful data to policymakers and decision-makers about their work.
